

**RELEASE OF LIABILITY, ACKNOWLEDGMENT  
AND ACCEPTANCE OF DANGERS AND RISKS  
OF PARTICIPATION IN CCR KIDS CAMP**

**DESCRIPTION OF ACTIVITY: PARTICIPATION AT CCR KIDS CAMP WHICH MAY INCLUDE BUT IS NOT LIMITED TO OUTDOOR PHYSICAL ACTIVITIES, SWIMMING, TENNIS, GOLF, DANCE, KARATE AND MARTIAL ARTS, COOKING AND OTHER KID'S ACTIVITIES.**

In consideration for the above-named Parent/Guardian/Member individually, on behalf of their family and the above-named Minor Participant (collectively "Releasing Party") being allowed to have the Minor Participant participate in the above-described activity ("Activity") at Country Club of Roswell (the "Club"), the undersigned agrees as follows:

1. The risks of both minor and serious injury from the Activity are significant.
2. **RELEASING PARTY KNOWINGLY AND FREELY ASSUMES ALL SUCH RISKS**, both known and unknown including, without limitation: injuries, heat exhaustion, slip and falls, other health related issues, and even paralysis and death in rare instances.
3. Releasing Party agrees that they will comply with any and all rules, regulations or instructions that may be provided to me regarding participation in the Activity. If, however, the Releasing Party observes any unusual significant hazard during the Activity, Releasing Party will remove their Minor Participant and/or themselves from participation and bring such knowledge to the attention of the Club immediately.
4. **RELEASING PARTY HEREBY ACCEPTS ALL RISK TO THE MINOR PARTICIPANT'S HEALTH AND INJURY OR DEATH THAT MAY RESULT FROM SUCH PARTICIPATION AND THE RELEASING PARTY HEREBY RELEASES MACGREGOR DOWNS COUNTRY CLUB, LTD, THE CLUB, AND ANY THIRD PARTY ACTIVITY PROVIDER ON WHICH ALL OR ANY PART OF THE ACTIVITY OCCURS, AND EACH OF THEIR AFFILIATED ENTITIES, AND ALL THEIR RESPECTIVE OFFICERS, BOARD MEMBERS, DIRECTORS, AGENTS, CONTRACTORS, EMPLOYEES, HEIRS, AND SUCCESSORS, ("RELEASED PARTIES") FROM ANY AND ALL LIABILITY TO RELEASING PARTY, PERSONAL REPRESENTATIVES, ESTATE, HEIRS, NEXT OF KIN, SUCCESSORS AND ASSIGNS, FOR ANY AND ALL CLAIMS AND CAUSES OF ACTION FOR LOSS OF OR DAMAGE TO PROPERTY, AND FOR ANY AND ALL ILLNESS OR INJURY OR DEATH TO MINOR PARTICIPANT THAT MAY RESULT FROM OR OCCUR DURING PARTICIPATION IN THE ACTIVITY. I FURTHER AGREE TO INDEMNIFY AND HOLD HARMLESS THE RELEASED PARTIES FROM LIABILITY FOR THE INJURY OR DEATH OF ANY PERSON(S) AND DAMAGE TO PROPERTY AS WELL AS INCLUDING LEGAL FEES ASSOCIATED WITH THE DEFENSE OF ANY CLAIM THAT MAY RESULT FROM PARTICIPATION IN THE ACTIVITY.**

This is to certify that the Releasing Party, as parent/guardian/member with legal responsibility for the Minor Participant named above, consents and agrees on his/her behalf to all of the foregoing conditions to participation and to the release as provided above of all the Released Parties, and, for the undersigned, Minor Participant, my child and our heirs, assigns, and next of kin, and do release and agree to indemnify and hold harmless the Released Parties from any and all liabilities including attorneys' fees in defense of any claim incident to Minor Participant's involvement or participation in the Activity, including, without limitation, any claims that Minor Participant may make against the Released Parties and any claims that the undersigned may have as a result of any injury to Minor Participant to the fullest extent permitted by law.
