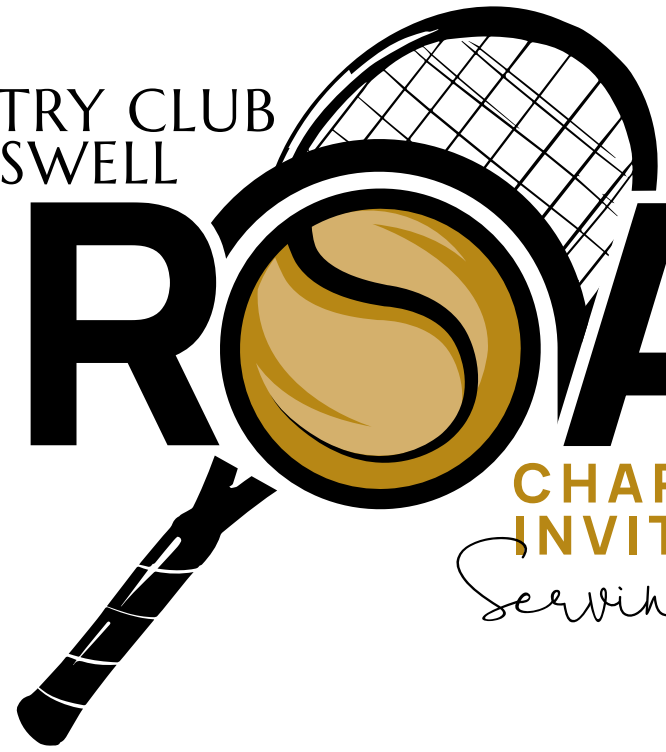

Special Pops Tennis offers an adaptive tennis program specifically designed to share the lifetime sport of tennis with children and adults with intellectual disabilities. The program offers these special athletes the ability to build self-confidence and life skills through social interaction with each other, and the many dedicated volunteers who run the programs.

Since the early 2000s, several Country Club of Roswell members and coaching staff have been active volunteers and served as board members of Special Pops Tennis. CCR is also one of the training sites these athletes and volunteers come together to: Play Tennis. Make Friends. Live Life! In 2023, Special Pops started a program on the Georgia Tech campus, and began helping athletes throughout Georgia to prepare and to assist monetarily for the Special Olympics Georgia State Games to be held in 2024.

StandUp for Kids works to end the cycle of youth homelessness and its economic impact by providing support and resources to youth experiencing hardships beyond their control.

Over the past 11 years, Country Club of Roswell's Pro-Am has helped at-risk youth in North Fulton by supporting StandUp for Kids. Through the years, it has been our privilege to meet several impressive, inspiring young people who—despite the hardships of homelessness—have completed their high-school studies and continued their education in college. In 2023, the Atlanta Chapter doubled the number of students being mentored. During the 2022-23 school year, 100% of StandUp for Kids students graduated or stayed in school with a zero dropout rate. This is a new record for SUFK.
